6. Accidental release measures

Personal precautions

7. Handling and storage

7. Handling and storage

Storage

: Store in accordance with local regulations. Store in approved area. Eliminate all ignition sources. Separate from oxidizing materials. Keep container tightly closed and sealed until ready for use. 
