#### First aid measures

#### **Eve contact**

: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower evelids. Check for and remove any contact lenses. Get medical attention if irritation occurs.

#### Skin contact

Flush contaminated skin with plenty of water. Continue to rinse for at least 10 minutes. Get medical attention. Remove contaminated clothing and shoes. Wash contaminated clothing thoroughly with water before removing or wear gloves. Wash clothing before reuse. Clean shoes thoroughly before reuse.

#### Inhalation

: Get medical attention immediately. Move exposed person to fresh air.
